### **CALL TO ORDER**

Chairman Johnson called the meeting to order at 4:02 pm. The meeting was properly advertised on the County website.

### **AGENDA APPROVAL**

The Agenda was approved as presented.

### **MINUTES**

The minutes from the February 16, 2023 Board Meeting were presented. Board Member Patton made a motion to approve the minutes. Board Member Dubois seconded the motion. Motion passed.

### **OLD BUSINESS**

- Supervisor Reynolds stated that the purchase of 2 additional Poll Pads and 10 printers were approved for purchase by the County and they requisition will be submitted for purchase. Chairman Johnson brought up concerns regarding poor cellular service in Richmond Hill possibly interfering with the voting process. Supervisor Reynolds and Mrs. Chapman reassured him that it would not be an issue.
- City of Richmond Hill IGA is still waiting for approval from Richmond Hill City Council before coming to the County. Mrs. Downs stated that there was a lot of back and forth between the City and County attorneys. It was also discussed that the Wetlands Center will not be used for Early Voting for the City of Richmond Hill since there is also a SPLOST and there will be a Countywide Election.

### NEW BUSINESS

- Supervisor Reynolds introduced Olivia Chapman as the new Elections Supervisor, Cindy's last day will be April 21<sup>st</sup>. Reynolds stated that Mrs. Chapman is already doing a tremendous job in the short time that she has been here and Reynolds feels confident in leaving.
- Staff will be attending a Regional meeting in Liberty County on April 27<sup>th</sup> to discuss various topics, including EPULSE.
- Supervisor Reynolds stated that staff continues to process all items on the GARVIS dashboard as the State is still making updates to the system.
