Commissioner Daniel left the meeting at 4:37 p.m.

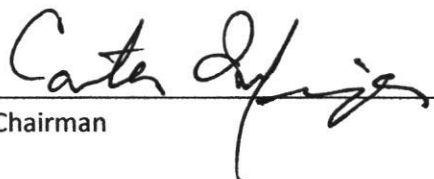
