## Sex Offender Residence/Employer Proximity Form

On May 20, 2010, revisions to the Georgia Sex Offender Laws took effect. As you were previously advised, some changes affect your proximity to locations where children congregate and the annual re-registration requirement. The Bryan County Sheriff's Office will enforce the revisions to the laws:

1. Sex offenders must register with the Sheriff of the County in which he/she will reside within **72 hours** after release from custody or being placed on probation, parole or supervised release or entry into the State. **Violators will be arrested.**
2. Sex offenders **must renew** their required registration information **in person at the Sheriff's Office within 72 hours PRIOR** to their birthday each year to be photographed and fingerprinted.
3. If your date of offense was committed **PRIOR TO JUNE 4<sup>th</sup> 2003 (42-1-17)**, there are "NO" Residency, Employment or Volunteer Restrictions, however, you shall adhere to "**ALL**" Registration Requirements. This also includes **Sexually Dangerous Predators** for this time frame.
4. If your date of offense was committed between: **JUNE 4<sup>th</sup> 2003 - June 30<sup>th</sup> 2006 (42-1-17)**, you shall not reside within 1,000ft of any **Child Care Facility** (all public & private pre-kindergarten facilities, day-care centers and preschool facilities), **School or Areas where Minors Congregate** (public/private parks, recreation facilities, playgrounds, skating rinks, neighborhood centers, gyms, and similar facilities providing programs or services directed towards person under 18 years of age).

For this time frame there are "NO" Employment or Volunteer Restrictions but you must adhere to "**ALL**" employment and volunteer requirements for registering. This also includes **Sexually Dangerous Predators** for this time frame. **\*\*If you the Offender Owns or Leases AND Resides** on such property and one of the prohibited locations for this TIME FRAME locates itself with 1000ft and Offender provides proof of OWENERSHIP or LEASE, and resides there then they would be EXEMPT from these provisions for the length of the Lease\*\*.

**\*\*\*\*CHURCHES, BUS STOPS, SWIMMING POOLS, LIBRARIES DO NOT apply to this time Frame for Residence\*\*\*\***

5. If your date of offense was committed between: **July 1<sup>st</sup> 2006- June 30<sup>th</sup> 2008 (42-1-16)**, you shall not reside within 1,000ft of any **Child Care Facility** (all public & private pre-kindergarten facilities, day-care centers and preschool facilities), **Church, School or Areas where Minors Congregate** (public/private parks, recreation facilities, playgrounds, skating rinks, neighborhood centers, gyms, **school bus stops, and public/community swimming pools**). You shall also not be **Employed:** at or within 1,000ft of a **Child Care Facility, Church or a School.** **\*\*\*\*\*LIBRARIES DO NOT apply to this time Frame for Residence\*\*\*\***

Sexually Dangerous Predator same as above employment restrictions plus the **Areas Minors Congregate** are included as restrictions (**with the exceptions of Libraries**). Sexual Offenders and Sexually Dangerous Predators shall not **Loiter (Code Section)** at any of the above restricted areas.

6. If your date of offense was committed between: **July 1<sup>st</sup> 2008- or after (42-1-15)**, you shall not reside within 1,000ft of any **Child Care Facility** (all public & private pre-kindergarten facilities, day-care centers and preschool facilities), **Church, School or Areas where Minors Congregate** (public/private parks, recreation facilities, playgrounds, skating rinks, neighborhood centers, gyms, school bus stops, public/community swimming pools and **public libraries**). You shall also not be **Employed by or Volunteer:** at or within 1,000ft of a **Child Care Facility, Church or a School.**

Sexually Dangerous Predator has the same as above restrictions plus **Areas Minors Congregate** for employment. Sexual Offenders and Sexually Dangerous Predators shall not **Loiter (Code Section)** at any of the above restricted areas.
